



REQUEST FOR EXPRESSION OF INTEREST FOR PROVISION OF OVERSIGHT SERVICES ON PUBLIC PROCUREMENT IN KENYA

**(Extension of Submission Deadline: From 22nd
September to 29 September 2008)**

The Kenya Institute for Public Policy Research and Analysis has received a Grant under the USAID Development Assistance Grant Agreement No. 615-009 between the Government of The United States of America (USA) and the Government of the Republic of Kenya (GOK). This Grant will support a number of activities under the Millennium Challenge Account Threshold Program (MCA-TP) aimed at reforming Kenya's public procurement systems and improving delivery of healthcare services throughout the country.

This Request for Expression of Interest (EOI) is targeted at Component 3 of activities under the aforesaid Program. The Component aims at including Non-State Actors (NSAs) such as (but not limited to) civil society, community-based organizations and professional bodies in playing a vibrant independent role in monitoring the implementation of Components 1 and 2 of the MCA-TP.

It is envisaged that the independent NSAs would enhance public confidence by complementing the Public Procurement Oversight Authority (PPOA) and KEMSA—who are simultaneously engaged in internal monitoring and evaluation work—as well as other relevant public bodies, in achieving the objective of increasing transparency and accountability in the procurement function and delivery of healthcare services of public entities.
